### Introduction

Violent relationships, whether between current or former intimate partners or family members, have severe consequences for victims, their families, and their communities. While most abusive relationships do not end in death, a significant number of them escalate to homicide. The Bureau of Justice Statistics estimates that three women lose their lives at the hands of intimate partners every day in this country. Each year, the Arizona Coalition Against Domestic Violence records the number and circumstances of fatalities due to domestic violence in our state by utilizing news reports, and we have seen the numbers rise over the past few years. Because of our method of data collection, we know that our statistics do not accurately reflect the actual number of fatalities.


Over the last four years, at least 458 people died due to domestic violence in Arizona. In 2005, 95 people died, and in 2006, 111 people lost their lives. The last two years have seen 126 fatalities in each year. These stark numbers show the real cost of violence between intimate partners and family members.

The complicated dynamics of domestic violence make it a difficult issue for some to grasp. The relationship may start out normally and may continue that way for some time, but abuse may begin with insults and isolation from family and friends. The violence usually escalates and may be verbal, emotional, physical, sexual, or may contain elements from all of those categories. These acts of violence are different in the context of abuse than when used against strangers or even friends. Perpetrators utilize a series of behaviors which create a coercive, controlling atmosphere that leaves victims dependent on them for all of their emotional and often financial needs. These acts, however, are intermingled with acts of love and healthy behaviors, adding to the victim's confusion. The time immediately after a victim leaves an abusive relationship is statistically the most dangerous, as the abuser may attempt to gain his or her power back through violence. Several of the homicides in this report were committed after separation or during arguments about the status of the relationship.


Others who died were abusers themselves. Many of them committed suicide, some in the context of assaults on their partners. Others who killed themselves also killed or attempted to kill their partners, family members, or bystanders before taking their own lives. Still other perpetrators were killed by police when they responded to a domestic violence call.


Domestic violence services in Arizona have provided safety, shelter, and other types of assistance to thousands of victims and their families. Each year, the National Network to End Domestic Violence performs a national census to provide a snapshot of service provision within one 24-hour period. The 2008 census, with 25 of 32 programs reporting, showed that residential domestic violence programs provided 1,230 victims with emergency shelter or transitional housing. An additional 186 adults and children received other assistance, such as counseling, legal advocacy, support groups, and others, widening the safety net and providing critical stabilization and healing services.

While many victims found shelter, an additional 119 requests for services were unmet due to lack of available beds, staff, or funding.





**Cause of Domestic Violence-related Death** 







Relationship Between Deceased and Perpetrator 2006






Relationship Between Deceased and Perpetrator 2008

### Conclusions

#### Gender

The report shows that the majority of the fatalities (59%) were male. However, the perpetrators of these crimes were rarely intimate partners; of the cases where age was available, only 10% of the adult male fatalities were homicides perpetrated by current or former intimate partners. Adult men were much more likely to be killed by another family member, police responding to a domestic violence call, or to have committed suicide. Additionally, some male homicide victims were murdered by their current partner's ex-boyfriend or ex-husband.

Adult females, on the other hand, were more likely to have died at the hands of a current or former intimate partner. Of the cases involving females over the age of 18, 68.6% were killed by a current or former intimate partner.

These findings are consistent with national research. The Bureau of Justice Statistics has repeatedly shown that women are more likely to be killed by an intimate partner than men.

#### <u>Firearms</u>

Throughout all four years, firearms were the most common weapon used. Out of the 458 fatalities, 262 of them were due to gunshot wounds (57%). More people died of gunshot wounds than all of the other causes of death combined. An additional two victims were shot along with another form of violence, but since the cause of death was not listed, they were categorized as "other."

National studies validate these statistics. When examining risk assessment, weapons are highly correlated to intimate partner homicide. Being threatened or assaulted with a weapon increases the risk of murder by 20. A gun's presence in the home left abused women six times more likely to be killed than other abused women.<sup>1</sup>

Dr. David Adams interviewed several abusers who had been convicted of killing their partners and found the link between guns and homicide to be incredibly strong as well. In one study of those who killed their intimate partners, of those who killed with guns, 78% said they wouldn't have used another weapon. "A gun depersonalizes... I wouldn't have gone through with it if I had time to think about it." One killer strangled his victim, but noted: "If I'd had a gun, I would have used it earlier; that's why I didn't keep one in the house." Of the killers who stabbed their victims, 4 out of the 6 said they would have used a gun had one been available.<sup>2</sup>

People who are convicted of a qualifying misdemeanor domestic violence crime or who have a qualifying order of protection against them are prohibited possessors under both federal and state law. Some of the homicides in this report cited killers who were either subject to an order or had a history of domestic violence and should not have been in

possession of a firearm. Several of the victims were killed by people whom they dated; since dating relationships are not currently included in the domestic violence statute, these victims are not eligible for orders of protection. Some of those victims had filed for injunctions against harassment; an injunction against harassment does not prohibit possession of firearm.

#### Patricide and Matricide

Over the last four years, Arizona has seen a sharp increase in the number of children and adults killing their parents. The 2008 case in St. John's made national news; an 8 year old boy was charged with the double homicide of his father and his father's housemate. Over the course of the year, however, there were 11 other victims killed by their adopted or biological progeny. This is a drastic increase from the previous three years: 2005 had 2 such cases, 2006 had 3, and 2007 had 7. In 2008, all of the patricide and matricide cases were perpetrated by boys and men aged 8-32, with 4 perpetrators' ages unreported.

The reports of the 2008 homicides revealed that three of these perpetrators were suicidal. One had placed suicidal messages on his MySpace page, one attempted to kill himself immediately after the murder, and one completed his suicide attempt.

One of the deaths was a shooting in self-defense after the boy's father attacked him with a knife. In two other cases, the perpetrators alleged abuse against the parent they killed.

#### The System

As stated in the introduction, services are available for victims and their families. These services include shelter, but residential programs provide far more than meals and a bed. Legal advocacy, individual and group counseling, and child care are essential tools for survivors leaving abusive relationships. Last year, over 10,000 victims were served by programs in 13 counties across Arizona. The state has made significant advances regarding service provision; according to the Department of Economic Security, fiscal year 2008 was the first year in which more victims were served than turned away.

Safety is the first priority for victims, and a comprehensive service provision system can help protect and empower victims.

In addition to keeping survivors safe and providing tools to overcome victimization, perpetrators must be held accountable for their abuse. Orders of Protection must be enforced, both in regards to surrendering firearms and contact violations. Domestic violence crimes must be tagged as such to ensure that proper charges are filed, repeat offenders are known to the system, and appropriate consequences are imposed.

Arizona has lost citizens of all ages, races, religions, and socioeconomic statuses. This problem is not a private one, and the community must take a stand to support victims and hold perpetrators accountable. The cost of not doing so is simply too high.
